#### **244/13 New Homes Bonus Funding Scheme**

Councillors received a letter from AVDC inviting submissions for the scheme, with a closing date of 30<sup>th</sup> September 2013. Members discussed a number of possible projects which could benefit including extension of the Community Centre, a new proposed Community Hub building linked to the Citizens Advice Bureau, provision of Public Toilets and the proposed X444 bus link. Councillors also considered a number of projects incorporated in the Town Council's Parks Management Plan action list; to upgrade and provide further facilities throughout the town's parks.

Proposed by Cllr Newell, seconded by Cllr Whyte and **AGREED** that an expression of interest be submitted for the proposed new Public Toilets and those items in the Parks Management Plan.

The Town Clerk was requested to begin in-depth project work and costing to meet the submission deadline of 30<sup>th</sup> September.
