Bringing the villages to town

We are delighted to announce that everyone living in the outlying villages around Buckingham can now access our shops and other facilities on Saturdays.

The 135 bus service comprises five routes covering (a) Hogshaw, The Claydons and Padbury; (b) Water Stratford, Barton Hartshorn, Chetwode and Preston Bissett; (c) Thornton, Beachampton, Nash, Whaddon and Thornborough; (d) Calvert Green, Charndon, Marsh Gibbon, Poundon, Twyford and Hillesden; and (e) Shalstone, Biddlesden, Dadford, Chackmore, Leckhampstead, The Lillingstones and Akeley.

If you have friends and family living in these villages please let them know. These are circular routes giving users a couple of hours in which to do their shopping and have a coffee before returning home. Timetables are available from the Visitor Information Centre in the Old Gaol, or the Library. Fares are payable but bus passes will be honoured.

This service was "championed" by local representatives and the County Council Localities Manager, who secured a Local Area Forum (LAF) subsidy for the service in its first year. The LAF is a County Council grouping of town/parish councils, plus other agencies and organisations active in the wider Buckingham area. If the service is well received, it could be continued in further years providing that any running-cost shortfall can be met by further subsidies, possibly made up of contributions from the town and parish councils receiving the service, and Buckingham traders.

This is a long-awaited addition to the economic infrastructure of North Bucks, providing what is seen to be an essential step in the removal of disadvantage to those who might otherwise be isolated – there are many who cannot easily get to the shops without relying on friends and neighbours, or paying expensive taxi fares.



Christmas Parade

The 28th annual Christmas parade was held on Saturday 15th December. The theme was 'Christmas Around the Commonwealth'. The weather was sunny but cold and as in previous years a large crowd lined the street to watch the floats, walkers and marching bands go by. The parade assembles in Chandos Road and parades down to the old Cattle Pens and then back to Chandos Road.

Buckingham Town Council would like to thank the organisers and members of the public that gave up their Saturday morning and acted as marshals. We would also like to thank the residents of Addington Road who once again helped by removing their vehicles from their street, to allow the easy flow of traffic up and down Addington Road whilst the parade was on.

After the Christmas parade was over, people were able to go into the Community Centre to the annual **Community Fair**. Stall holders are made up of charities, local groups and societies, such as **Cancer Research**, **Guides, Brain Tumour Research** and **Buckingham Canal Society**. Mulled wine was provided by the **Wine Circle** and mince pies by the **CAB**.

Council Tax / Precept



There were a number of huge challenges facing the Town Council when setting the precept (the part of your Council Tax that goes to the Town Council) for the coming year.

The Council Tax base (the number of houses in Buckingham which are 'taxable') has decreased again. Last year it was 4,434 and now it is 4,393. This means that for each house to pay the same amount of tax, the Council had to find money from savings, reserves or increased Council Tax. Over the last two years the tax base has been reduced, even though 241 houses have been built in the town. If the exemptions for Council Tax had not happened, rather than seeing the precept income go down by £8,822, the amount the Town Council would have collected would have gone up by approximately £29,000.

In addition to this, Central Government has decided to reduce the cost of benefits that Billing Authorities (in our case Aylesbury Vale District Council) will receive. It will now be the case that Central Government will only pay 90% of the funding to cover the cost of providing support to those on Council Tax benefits. This has resulted in a massive drop in the Council tax base: a reduction of nearly 10%. Although this grant is available for the next year there is no guarantee that in future years the grant will be there. All this means the Town Council had to take some tough decisions about the budget.


While prices are rising, the Town Council would have to find $\pounds 55,634$ to ensure that each house would be paying the same Council Tax as in the previous year. This is out of a precept income of last year of $\pounds 538,546$. In other words an amount equivalent to 10.3% saving was required for the Town Council's precept to stay the same.

At the Town Council meeting on 21 January, the decision was taken to make large cost savings (but without damaging frontline services) this year so that there was no precept rise. We will be using the coming months to take a strategic look at our financial position so that we are fully prepared for next year's budgetary pressures, whatever they may be then.

Following on from the questionnaire in our previous issue we have now had over 100 pieces of feedback on the Neighbourhood Development Plan.

As a result of the responses the Town Council held a consultation workshop in the Community Centre on the 22nd February with stakeholders to focus on the potential re-development of the Town Centre. This gave stakeholders the opportunity to come along and give their opinions on the Town Centre of Buckingham and their thoughts on what improvements should be made.

The Town Council is also in the process of discussing with various groups in the town what their needs will be in the future, be this sports facilities or schools and doctors. Various meetings have already been held with more scheduled to take place. This will allow the plan to factor in increases in service provision if identified.

Over the coming weeks we will be starting to write policies for inclusion into the Buckingham Neighbourhood Development Plan with the aim of making Buckingham a better place. This is your chance to have a real say in how Buckingham should develop and grow in the next 20 years.



Help with oil costs



YOUTH COUNCIL

2012 was a busy year for the Youth Council, with the recruitment of three new Youth Councillors, participation in the Twinning trip to Mouvaux, and the planning of the Under 18s night in October 2012 which was unfortunately cancelled.

For the new year the Youth Council is looking at various events such as a skateboard competition and, if all goes well, a talent show, which will be more of an Open Mic thing - so it is open to all those wishing to perform. Details will be

available through the pages of this magazine so watch this space, and if you want to get involved, contact the Youth Council, details are below.

Recently the Youth Council has turned its attention to leisure facilities for young people and looks to pressure Aylesbury Vale District Council to improve both the Swan Pool, its facilities, and the services available to young people such as gym time and general pool times. At present there are very limited services available and the Youth Council feels that

this should change, with pool sessions for young people when schools close and gym time on a more convenient schedule. Obviously consultation would be needed as to the viability of this and the demand that may exist for young people, so if you feel strongly about this issue, get in touch, the details are below!

The Youth Council takes its role seriously and is looking to take up any cause that may be important to young people. The Youth Council is also planning its own website, which will hold details of Members and events and projects that are being considered. The Youth Council wants to do so much, but they need more members to help with planning these events and share the weight of organising. The Youth Council represents part of the commitment that Buckingham Town Council makes to the young people of our parish to make sure that their voices are heard and influence the direction of the town. We also know how important it is that young people are given the space to have fun, make friends and grow up into the amazing adults they will become. Therefore the Town Council has also granted £750 to Project Street Life and £20,000 to the Buckingham Youth Club over the last two years in

order to support both of these important services for local young people.

Floodaction4Buckingham

Flooding in Buckingham happens on a regular basis.

Local Councils and the Environment Agency have done a great deal to help house holders of Buckingham since the last two major flood events in 1998 and 2007 through a grant which has helped to increase the flood resilience of their properties. In addition, a local group of volunteers has formed a flood action group (FA4B) to monitor issues with the river, drainage and, during a time of flood, to assist residents as necessary.

FA4B believe that the best way to reduce the effect of flooding is to have both a town and personal flood plan. In the event of a flood, it is very likely that plans will be put into action in the middle of the night. So, it is important to know where your flood defences are stored and ensure they are maintained and work effectively. On July 6th 2013, FA4B together with the Environment Agency, Emergency Services and the



National Flood Forum will be holding a dry run event in the centre of town to promote the Buckingham Flood Plan and to encourage householders to prepare and practice their personal flood plan.

This personal plan will be different for all of us but some things are common, for example move all valuable and portable items upstairs, especially personal items such as photographs etc. If you wish to find out more about writing a flood plan please contact FA4B.

During the recent flood warnings, people already on the FA4B list have said they were reassured by the regular update and information sent to them. If you have not yet signed up, please send an email to floodaction4buckingham@yahoo.co.uk and mark your email: "Add Me To Your List".

New Play Area in Bourton Park

You may have noticed a new play area appear in Bourton Park recently; this new area will provide an exciting new play opportunity for the young people of Buckingham for many years to come.

The Town Council conducted a consultation with schools in Buckingham to find out what local children wanted from the new play area and as a result the new area will include a Zip wire, Basket Swing, a spinning dish, a central 'Tree House' playhouse with a tube slide and scramble net and an adventure trail. The equipment will be made of natural timber to help the equipment fit in with the surrounding trees.

The children who were asked what they wanted to see in the new play area didn't forget the parents either, one of the things they asked for was a comfortable area for mums and dads to sit, so the new area will have a specially designed seating area for the parents as well.

This area was installed by the Town Council with funding also coming from both Section 106 funding (property development contributions) and WREN (Waste Recycling Environmental Ltd) which is a not-forprofit business that helps people who live close to landfill sites by awarding grants for community, conservation and heritage projects.



Cllr. Mike Smith, Chairman of Buckingham Town Council's Environment, Property & Health Committee, said "This project not only provides some much-needed improvements to a long-standing play area, but it incorporates some additional facilities thanks to the generous WREN funding. I am particularly delighted that the project will now incorporate some play equipment that our young people particularly wanted". **www.wren.org.uk**
