To consider whether the Town Council needs to commission extra technical support in order to respond to the VALP consultation and agree a budget (from contingencies) if decided so to do.

Cllr. Harvey spoke to the above motion, stating that the Town Council needed to form a response in consultation with neighbouring parishes such as Winslow and Haddenham and should consider asking for extra technical assistance. Cllr. Smith suggested a remuneration amount reflective of the (pro rata) figure budgeted for previous extra technical work on the Buckingham Neighbourhood Development Plan. Cllr. Hirons seconded the motion.

An amendment to the motion proposed by Cllr. P. Collins, seconded by Cllr. Hirons and unanimously **AGREED** to consider whether the Town Council needs to commission extra technical support in order to respond to the VALP consultation and agree a budget (from contingencies) if decided, to be remunerated at the same rates (plus any cost of living addition) as the legal assistance provided for the Buckingham Neighbourhood Development Plan for up to 10 working days.
