2375 REPORTS FROM BUCKINGHAM TOWN COUNCIL'S REPRESENTATIVES ON OUTSIDE BODIES

To decide if the Council wishes to nominate a replacement for Grenville School

The Clerk explained the implications of the recent Education Act which has removed the Minor Authority Governor from the governors' listings. When under taking a reconstitution, which all governing bodies will have to undertake prior to 2006, they can choose to designate a Community Governor for the previous role of the Minor Authority Governor or work with the County Council to have them as a designated LEA Governor. No Member volunteered to take on the role as the Town Council's representative on Grenville School's Governing Body.

The Mayor informed Members that Bourton School had already undergone a reconstitution and he had been requested to stand as a Parent Governor; the Clerk had written to the Chairman of Governors informing him that it was inappropriate for the Town Council's representative to be elected as a Parent Governor, a view endorsed by the Members.

2376 ACCOUNTS FOR PAYMENT

Proposed, seconded and RESOLVED that the invoices per attached list be approved.

2377 ACCOUNTS FOR RETROSPECTIVE PAYMENT

Proposed, seconded and RESOLVED that the payments made per the attached list be approved.

Members queried the invoices and retrospective payments attributed to the Mayor's Allowance account shown in the listings, feeling that such payments should not be shown as a separate entity. The Clerk explained that all cheques written from the Town Council's account have to be shown in the listings for audit purposes. The Clerk confirmed that in previous years the Mayor's Allowance had been paid in two half yearly amounts, on request, to the Mayor.

Proposed by Cllr. Lehmann, seconded by Cllr. Cadd, and **RESOLVED** that the Mayor's Allowance is to be paid in two half yearly amounts.

2378 REPORT FROM MR MACKEY ON SID SURVEY IN NOVEMBER 2003

Members discussed the information on the average speed of vehicles passed Gawcott Field houses taken with the use of SID (Speed Indicator Device). This had indicated that the average speed was just over 49 mph.

Cllr. R. Newell arrived

Members agreed to send a copy of the report to Thames Valley Police Traffic Unit asking for their comments.

Following a question it was confirmed by the Clerk that the Town Council could borrow SID again but Members need to be aware of the commitment required by Councillors to be with the machine and record the data.

Concerns were raised by a Councillor that the signage on Gawcott Hill Road on leaving the by-pass was inadequate. Members were reminded that the County Council are conducting a review of all the speed limits.

2379 NOTIFICATION OF CRIMINAL DAMAGE TO THE ENTRANCE DOOR

Members were informed that some time between 9th and 12th of January graffiti was sprayed on the Town Council's entrance door; this had been reported to the Police.

2380 NOTIFICATION OF DAMAGE TO PROPERTY AT CHURCH HILL

Members were informed that part of the boundary wall between Church Hill and Hill House had collapsed; this wall is owned by the Town Council and the Owners of Hill House and any claim on the insurance will be 50/50. The Clerk was obtaining quotations from 3 builders.

Proposed by Cllr. Cadd, seconded by Cllr. Isham, and **RESOLVED** to claim for 50% of the rebuild cost from the Town Council's Insurers and the Town Clerk to have authority to pay the £250 excess on the claim.

2381 COMMENTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr. D. Isham reminded members that the Parishes Forum would be held on 24th February 2004 in Newton Longville.

2382 TOWN MAYOR'S ITEMS

2382.1 Community Plan Working Group

The Mayor informed members that Mrs. J. Good who had been employed by Buckingham Town Council on behalf of the Working Group had resigned; no reason was given. Cllr. Barnett who is a member of the Working Group has volunteered to complete the outstanding work to produce the action plan; Members thanked Cllr. Barnett for rescuing the project.

2382.2 Parking Charges

The Mayor reported on the District Council's budget meeting which he had attended with Cllr. Lehmann. The Meeting had agreed to introduce parking charges in Buckingham, but, Members were informed, the District Council was meeting on 3rd March 2004 to discuss the principle on rural parking which may have bearing on the charges levied and also may open the possibility of leasing the car parks. Members discussed the option briefly, in particular the policing of the car park, the systems to maintain the long and short stay sections, and also the lack of maintenance over the years resulting in potholes, damage to the paving, and poor lighting.

Proposed by Cllr. Lehmann, seconded by Cllr. Cadd, and **AGREED** to write to Mrs. V. Baxter - the relevant portfolio holder - expressing the Council's interest in discussing the leasing of the car parks.
