At present, Minor Amendments to applications arrive in the weekly envelope otherwise unannounced (i.e. there is no listing on the website or in the Bulletin) with a cover sheet note as follows:

"I enclose copies of revised drawings which have been submitted in relation to this application.

We do not feel that it would be appropriate to undertake a further round of consultation on these amendments, which we consider to be minor in nature.

Whilst we have provided these drawings for information purposes, if you do have any queries or further comments, please contact the case officer.

It is intended that the application will now proceed to determination."

Members will have noted that applications have often been determined before they have had any opportunity to comment on the amendments, the decision appearing on the same agenda as the amendment notification.

Planning North have contacted us as a problem has arisen with applications Members had opposed for a specific reason, and the minor amendment cancels the objection; for example Members may have asked that an extension roof be made clearly subsidiary, and this has been done. At present, because no further comment is made, the application must still go to Development Control for decision because of the original OPPOSE response. No mechanism exists for withdrawing opposition.

If the change to the original merits the designation Amended Plans, then the whole planning cycle with advertisement etc. is re-activated, Members see the Amended Plans and respond as if to a new application, decision is made in due course; this takes time.

Members are asked to consider a policy for Minor Amended plans:

- Do Members wish to re-consider for comment in all cases where the original response was to oppose?
- Do Members wish to delegate responsibility to the group of three able to decide planning matters in the event of a non-quorate meeting as per Standing Orders when the minor amendment effectively cancels the reason for opposition?
- Should such amendments be considered 'Minor', or re-listed as Amended Plans?
- Should Minor Amendments be listed in the Bulletin and on the website? Note that under the present system Minor Amendments that arrive in the last envelope before the meeting would have to be on a Supplementary Agenda if they were to be commented on as the envelope is received on the Thursday at the earliest. Applications from this last week are taken from the website listing on the Tuesday in order to have as complete Agenda as possible to send out to Members.
