## **4734 PLANNING - OTHER MATTERS**

# 4734.1 (4694.2) Street Naming – Cornwall's Meadow car park access road

Street Naming had reported that the road was already designated as Cornwall's Meadow and offered to install name plates to this effect.

Members agreed that this would be useful.

## 4735 CORRESPONDENCE

# 4735.1 (4723.1) Response from AVDC over proposed housing

AVDC Forward Plans Dept. had replied that the allocation of the 3300 new houses suggested in the MK and South Midlands Study would take place via the Local Development Framework for Aylesbury Vale when available. There would be public consultation during the process of developing the LDF.

# 4735.2 04/02886/APP 4/6 Fox Way: Reasons for AVDC decision contrary to BTC response

Members had opposed: Members felt that such a large extension, though 'subsidiary', to the boundary of the property on a corner plot closed off the view and affected the balance of the street scene. Members supported the pitched garage roof.

AVDC: The Committee noted that as the dwelling occupies a corner plot the proposed development would have some impact on the street scene. However, it was considered that sufficient space would be retained around the dwelling to ensure that the proposal would not result in overdevelopment of the site nor detrimental to the street scene, in particular, views across the corner.

#### 4735.3 Traffic Calming – Chandos Road

BCC was proposing to send a letter to residents and interested parties seeking their views on the traffic situation in Chandos Road, and had sent the Town Council a copy of the letter for comments.

Members felt the content of the letter was acceptable; trusted that the comments box would be an adequate size; and asked that the County Council send the letter to the residents of Chandos Road and Chandos Close, including those in Chandos Court individually; to the parents of pupils at Grenville Combined School, Royal Latin School and Buckingham School via the School Newsletters or PTA; to the University and St Bernardine's Church; to the Bowls and Tennis Clubs; and to the residents in McKenzie Close and the stretch of Bridge Street between Ford Street /Bourton Road and the river; and the Town Council.
