2562.1 Buckingham Community Wildlife Project

Members received the minutes of the Buckingham Community Wildlife project dated 11th February 2005.

<u>2562.2 Buckingham General Charities – representatives</u>

Members **AGREED** that Cllr. Isham and Cllr. Newell, who had expressed willingness, continue as the Town Council's representatives on the Buckingham General Charities.

2562.3 Youngsters Cinema

Members received the minutes of the Youth Cinema group dated 7th February and 28th February 2005. Cllr. Stuchbury explained the current position concerning the cinema

project and in particular the role of the University; this was being established in conjunction with the Buckingham Centre for the Arts main cinema project. There was some concern that it had been reported that the university would be charging £100 a time for the use of the equipment that will be purchased by the Buckingham Centre for the Arts Group. Neither representative was able to confirm the exact funding set up once the projects were in full use but would keep Members informed as they were unaware of the quoted £100 fee.

2562.4 Buckingham Twinning Association

Members received the minutes of the Twinning Association dated 2^{nd} February and 2^{nd} March 2005. All Councillors were urged to support the events run by the Twinning Association and in particular the annual visit on $4^{th} - 6^{th}$ November.

2562.5 Bourton Meadow School

Cllr. Stuchbury as the Minor Authority Governor reported on concerns he had over the financing and the management of the Bourton Centre. As a governor he is aware that the school intend using the Bourton Centre for the 3-year-old classes. The Bourton Centre was built as a community facility and not as an extension to the school facilities. Members expressed concern and asked the County Councillor to investigate; Cllr. Cadd agreed.

2562.6 Buckingham Community Plan Working Group – Cllr. Barnett

Cllr. Barnett asked that the title be changed to the Buckingham Community Plan Steering Group. Over 30 people are now involved with the Steering Group and its Committees. It is intended that a public meeting will be held in June and with a newsletter being delivered around the same time.

2562.7 Buckingham Community Centre

Cllr. P. Strain-Clark as the Town Council representative reported that the Community Centre AGM would be held on Thursday 17th March at 7.30 pm; all Councillors were asked to attend.

A question was asked in respect of the invoicing for the refurbishment of Moreton Road Toilets: the Clerk confirmed that no invoice from AVDC had been received although it is understood they had paid an amount to the contractors.

2565 REPORT AND DISCUSS THE ADMINISTRATION, DOCUMENTATION AND PROCEDURES AS A BURIAL AUTHORITY

Cllr. Mordue informed Members that since the taking over as the Burial Authority we have dealt with 11 burials, an average of 2 a week. The Town Clerk and the Contractors were thanked for all their work ensuring the smooth running of the Cemetery despite being given such short notice. Members discussed the legal documents required for the management of the Cemetery; these include the Burial Register, the Grave Register, Purchases Register and the Maps. Unfortunately not all the paperwork has been received yet from AVDC causing some temporary difficulties. Cllr. Mordue and the Clerk reported on the Cemetery Managers Liaison Group meeting they had attended in Rugby.

2566 COMMENTS FROM DISTRICT AND COUNTY COUNCILLORS

Cllr. H. Lewis informed members that the new budget for AVDC financial year 2005/2006 had been approved showing a 9.2% rise in the Council Tax.

Cllr. Cadd and Cllr. Isham spoke on the forthcoming speed review which deals with Gawcott Fields; both Councillors expressed support for the lowering of the speed limit in that area to 30 mph.

2567 MAYOR'S ITEMS FOR INFORMATION.

Brookfield Lane and the development at Grenville Cottage

The Mayor explained that he had received a letter from a resident expressing concern over the works traffic at the Grenville Cottage site. They had written to Bucks. C. C. but had not received a reply. Members had also noted the comments made at the public session earlier in the evening.

It was **AGREED** to establish what if any conditions County and District Councils had placed on the developer; Cllr. Cadd as a County Councillor would obtain information and establish why no response had been sent to the complainant.
