Pay award

Negotiations are ongoing between Central Government and the National Joint Council they are due to meet at the beginning of June to discuss each side's position re offered and demanded amounts. As a local authority the staff wages are linked to the pay award which when decided will be back dated to 1st April 2007.

THE 2007 CLAIM - as issued by the joint unions on NJC

The joint NJC trade unions have lodged the following claim with the employers:

- 1. One year only
- 2. 5% or £1,000 whichever is the greater
- 3. To ensure a £6.30 underpin on the minimum hourly rate
- 4. An increase in annual leave of 1 day for all employees
- 5. An increase in basic annual leave entitlement to 25 days per year as the minimum entitlement for all employees
- 6. A reduction in the standard working week to 35 hours, without loss of pay
- 7. To increase the night shift allowance over a 3 year period from a time and a third, to time and a half, to time and three quarters, to double time in the final year
- 8. An increase in the sleep-in allowance to £60 for residential workers

(30/3/07) At the meeting of the National Joint Council on 20 March the local government employers made an offer of 2% in response to the NJC pay claim.
