APOLOGIES FOR ABSENCE

Apologies were received and accepted from Councillor G. Loftus.

5176 DECLARATIONS OF INTEREST

The Chairman declared an interest in application 08/00994/AAD as a relative was employed by Waitrose.

Cllr. Mahi declared an interest later in the meeting as minuted.

5177 MINUTES OF THE PREVIOUS MEETING

Proposed by Cllr. Stevens, seconded by Cllr Hirons, and **AGREED** that the minutes of the meeting held on 25th March 2008, ratified on 14th April 2008, be accepted by the Committee.

There were no matters arising.

5163.1 Dark Alley

In light of representations made at the Public Session, Members discussed the gate and heightened garden wall in Waglands Garden. It was felt that an update on progress should be sought and the relevant property-owners notified of the Council's actions. The matter would be placed on the next agenda.

Sports Pavilion, Stratford Road

Replace external cladding & alteration to flat roof to pitched roof to sports pavilion. A majority of Members had supported the application in principle at the previous meeting but decided to oppose the application because there were inadequate details of the materials to be used. The Planning Officer had written, enclosing a copy of the same Design and Access Statement as originally submitted, asking whether the Council would reconsider its response given that AVDC could impose a condition in its permission requiring the submission of further details.

The Committee discussed the request at some length, noting that the D&A Statement listed optional colours and materials, and that there was some doubt whether the walls would be strong enough to support a tiled roof. It was felt that it was not this Council's remit to consider undefined applications; that no new information had been provided; and that the Planning Officer's letter indicated that AVDC required more details before approval.

Proposed by Cllr. Stevens, seconded by Cllr. Desorgher, that this Council holds to the original response given.

Cllr. Stuchbury, seconded by Cllr. Mordue, proposed an amendment that this Council support the application; this was defeated.

Cllr. Stevens' proposal was **AGREED**, Cllr. Stuchbury voting against and the Mayor abstaining.

Proposed by Cllr. Stuchbury, seconded by Cllr. Stevens, and **AGREED** that item 7.1 be taken next for the convenience of the residents present.

5180 (5172.4.2) BUCKS. WASTE & MINERALS CONSULTATION

Cllr. Whyte reported on the consultation documents reviewed by himself and Cllr. Mahi. The February 2008 document differed so substantially from the 2007 consultation that this Council responded to that it should be treated as a fresh consultation.

The sections dealing with mineral extraction could be ignored as this did not affect the north of the County at all.

The document is complex and ambiguous, and it is difficult to extract the implications of the alternatives offered. Only the sites are for consideration, not the processes planned for the site. Should the decision be for Wapsley Wood rather than Calvert, a sorting facility would be built on a 6.3ha site off Osier Way, and the sorted refuse would then be transported to Wapsley Wood. There was no indication that the inadequate road network in the north of the county had been taken into consideration, nor the proposed East-West Rail Link, when sites were considered. If the site was not working at full capacity with refuse from Bucks., it was likely the private developer would import from outside the catchment. The present Household Waste Site would have to relocate in any event, as it was too small, but there was no detail on this.

The consultation response is due by 25th April 2008; the submission document is planned to be available September 2008, with the Public Examination mid-2009 and adoption in 2010.

Cllr. Stuchbury reported on the meeting he had attended in Calvert involving several officers and an audio-visual presentation: there had been little information provided, and no supporting scientific data for the proposed incinerator, only verbal assurance

on the safety aspects. It was noted that the smell when Calvert brickworks was operational was frequently apparent in Buckingham, so it was likely that the incinerator fumes would also carry this far. No analysis of airflow appeared to have been carried out. He had not initially been allowed into the meeting, which was not attended by any of the County or District Councillors for Buckingham, and he felt that the town had been treated badly in the matter of opportunity for public consultation. He had asked about road capacity but received no response.

Members deplored the lack of consultation with local residents, especially as it appeared that Beaconsfield residents in a similar situation had received individual letters. The proposed site on Osier Way was too close to residential properties, adjacent to the town's Conservation Area, and occupying land in the industrial belt which could well provide employment for the increased population of the town. The plan was contrary to the County's own transport and sustainability policies.

Members were at liberty to add their own views to the consultation; the Committee's response would be circulated to Members for their information (and is appended to these Minutes). The Buckingham Society's response would also be circulated to all. A letter would be sent to Cllr. Tett (BCC Cabinet, Strategic Planning) expressing the Committee's concerns over the consultation process.

ACTION THE CLERK

Cllrs. Whyte and Mahi were thanked by the Committee for working through the document to produce the report, and Cllr. Mahi for attending the meetings.

White Hart Hotel, Market Square

Single storey extension to rear of building with alteration to fenestration and entrance on the rear elevation, laying out of car parking area, refurbishment of existing garden including new awning, pergola, bin store, lighting and garden furniture

Support was given subject to the reports of the Historic Buildings Officer and the Conservation Area Officer: Members noted that little attention had been paid to the guidelines in the Vision and Design Statement resulting in a proposal not related to the townscape, and that work had already started. Concern was also expressed that the parking provision (18 bays) did not meet AVDC parking guidelines of 1

space per bedroom for 20 bedrooms and staff accommodation for 7, let alone extra for the bar customers. Members also felt that some soft landscaping should be retained, and that any hard landscaping should be permeable.

Erection of illuminated fascia sign, hanging sign and various other signs Members would have preferred the style of the signage to reflect the Georgian period, rather than Victorian. Replacing the antlers on the porch representation of the hart was also suggested.

Conversion of garage into habitable room and enclosure of land for residential use Support was given subject to there being an adequate number of parking spaces after the loss of the garage space.

Cllr. Mahi declared an interest in the following application

08/00904/APP OPPOSE

Car Wash, Tesco Stores Ltd, London Road

Demolition of existing car wash and erection of new car wash centre

Members were very concerned at the loss of the landscaped barrier between the site and the road, which was thought to be the subject of a planning condition, and also the extensive alterations to the site evident from the drawings (but not the subject of this application) which included the loss of the landscaped area to the south of the present car park and re-siting of the recycling area and bus stop.

Members opposed because of the loss of landscaping and consequent visual intrusion of an inappropriate (both in style and materials) building in the street scene, and concerns at the amount of water to be used and the observed inability of the present drains to cope.

Members asked that the planning conditions re landscaping be checked, and that a site meeting be organised for Development Control Committee members.

08/00994/AAD PARTIAL SUPPORT

Waitrose, 14 Meadow Walk

Erection of freestanding, totem and various signage

Members were in general supportive of the application but expressed the following concerns:

(drawing 06) The service yard is not for the exclusive use of Waitrose: this sign could be read by the other delivery drivers to imply the opposite, leading to them attempting to park large vehicles in the main car park.

(drawing 10) Members were of the opinion that the existing cycle racks, installed by the County Council, were a better design for securing the cycle to and provided more cycle parking spaces than those proposed. The detail list indicates 6 planters although only 5 are shown on this and other drawings. Members suggested the existing stands be retained and painted with the corporate colour.

(drawing 12) The amalgamation of the entrance and exit doors and change of the existing exit to a window was felt to present access problems and a fire hazard. Members assume this will be the subject of a separate application so that appropriate comment can be made.

(drawing 20) Members were unclear as to what constituted a 'dog stop' and felt it was too far from the store entrance.

It was also noted that many of the drawings show a free-standing ATM with protective bollards; it is assumed that this will also be the subject of a separate application. Members feel that if an ATM is to be installed it should be in the store wall, both for security and so that blown litter, etc., cannot collect behind it.

5183 PLANNING - OTHER MATTERS

5183.1 (5172.2) To receive an update on the Buckingham Plan

The Chairman reported that he and the Mayor had collaborated on a questionnaire (an example was circulated at the meeting) to be sent to the consultee list agreed at a previous meeting. A modified version would be produced for residents to express individual views. He proposed a meeting with AVDC and BCC Forward Plans Officers to discuss the plan and elicit any issues the Plan Group needed to be aware of. The anticipated timetable was:

Public Launch at the Music in the Market on May 25th

1st workshop in May - discussion with responders on future development of the town – what/where/necessary infrastructure

2nd workshop June/July – social/education/employment/health/leisure/tourism issues

July (possibly 20th, final day of the Festival Fortnight) – reminder for public August – draft document for review by Committee and Council, seek feedback from consultees

September/early October – obtain Council approval of final document and submit to AVDC for inclusion in the LDF.

5183.2 (5159) To receive information on the progress of the Silverstone Development Brief

An explanation of the lack of acknowledgment and a copy of the Council's response as printed in the consultation report was circulated with the agenda.

5183.3 (F&A 380/2008) To review and discuss changes to the Committee's Terms of Reference prior to the Chairman's Group meeting.

A copy of the Committee's Terms of Reference was circulated with the agenda. Members felt that clause 3 should make more clear the role of the Committee to formulate response to consultations and consideration of planning applications. As the Committee now had a budget, there should be a clause similar to that of other committees giving delegated spending powers.

"but not vote" should be added to Clause 4.

5183.5 (5172.3) AVDC Local Strategic Partnership meeting

The Chairman described the LSP as a focus group AVDC was required to organise although its aims and structure were not defined in law. It had as yet no leader and lacked direction. Very few of the members were not connected to AVDC or BCC, and it was felt that the leader perhaps should be one of the remainder, or the interests of the non-Aylesbury part of the Vale would be subsumed.

Members pointed out that an AVDC or BCC Officer chosen as leader would have office support and hoped that similar support would be equally available to whoever was elected.

Cllr. Mahi declared an interest in the following item as an employee of Tesco.

<u>5183.6 To discuss the detrimental effect to the appearance of the Town Centre of Tesco Express' blue roller shutter.</u>

The shutter had been permanently down since Christmas; apparently this was because it was broken. Members felt that this had a detrimental effect on the appearance of the town centre. A letter would be sent asking that the shutter be mended as soon as possible and raised during shop opening hours.
