That Buckingham Town Council begin talks with Milton Keynes Council over the continuing growth of both Milton Keynes and Buckingham as with this development we are edging closer together.

I believe we should seek to start talks to ensure the growth of Milton Keynes will not adversely affect or over whelm Buckingham's services. The joint working should be a high priority due to the speed of the proposed growth (Milton Keynes increasing to over 300,000, 5,000 plus homes at Salden Chase and over 1,500 new homes in Buckingham) By working closely together in these early stages I hope that it will preserve and strengthen the town and its services going forward. We should not believe that AVDC will put Buckingham's needs first and need to take the initiative.
