Members stood for a minute in silence for the recently deceased former Mayor Councillor John Roberts. Cllr. Isham noted that Mr. Roberts had been the last Mayor of the Borough.

407/14 Apologies for absence

Apologies were received and accepted from Cllr. J. Harvey.

408/14 Declarations of interest

There were no declarations of interest at this point.

409/14 Minutes

The minutes of the Planning Committee Meeting held on on Monday 15th September 2014 ratified at the Full Council meeting held on 6th October 2014 were received and accepted. There were no matters arising.

Proposed by Cllr. Hirons, seconded by Cllr. Isham, and **AGREED** that the first application be taken next, for the convenience of the members of the public present.

OPPOSE AND ATTEND

7 Gawcott Fields

Single storey and two storey rear extension

Members felt that the small changes to the previous (withdrawn) application still left an overbearing extension too close to the boundary and with a window overlooking the neighbour's property, entailing loss of amenity.

The members of the public left the Chamber.

Members **AGREED** unanimously to resume agenda order.

Members agreed that 283.2.1 could now be deleted from the list, but that the unanswered March letters to Cllr. Neil Blake (829.2 & 832) should form the basis of a News Release to Mix 96 and 3 Counties Radio.

(545.3) Cllr. Strain-Clark reported that HGVs were still finding their way to Church Street; Cllr. Whyte assured her that the new signs would be installed soon.

The following application had been discussed earlier in the meeting (410/14) 14/02432/APP

Swan Pool and Leisure Centre, London Road

Double height extension incorporating new entrance lobby, single storey front extension and single storey rear extension

Members supported the renovations, but pointed out that there was no indication of the hard landscaping changes associated with the relocation of the main door, provision of cycle and motorcycle parking, and whether the existing car park was adequate to the presumed increased use of the building.

Comment was also made that the toilet provision on the viewing level had been reduced from 8 (3 male, 3 female, 1 disabled plus one by the front door) to 2 accessible cubicles, and that this may not be enough for a café environment.

Replace shop windows with tripartite timber sash windows.

14/02685/APP OPPOSE AND ATTEND

Former Railway Station Site, Station Road [land behind Station Terrace]
Erection of 6 dwellings (Amended scheme following approval of 14/00402/APP)
Having always considered that 6 dwellings was overdevelopment of the site,
Members agreed that further extension of the accommodation was inappropriate
and would have a detrimental effect both on Railway Walk and Station Terrace.
Concern was also expressed about the drainage of the site; apart from the greater
area to be covered by hard landscaping and thus a greater need for attenuation of
rainwater run-off, the springs in the land, which currently drain into the University
land and thence to Station Road could well be interfered with by the building
foundations and cause difficulties for existing residents. Connecting with Station
Terrace's sewers – which drain via the railway land – could well overload an elderly
system not intended to take the amount of water used by 6 large modern houses.
The depth of cutting into the sloping land will reach layers undisturbed by the
railway use, and Members asked for an archaeological investigation before building
work started.

14/02715/AAD CONDITIONAL SUPPORT

National Westminster Bank plc., 2 Market Hill

Replacement illuminated fascia and projecting signs and ancillary signage Members felt that the fascia board was too long, too bright and over-lit for the Conservation Area. The undercroft proposal was acceptable, though some thought that a floor-to-ceiling purple panel for the ATM was excessive. Members would be minded to reconsider their response if the fascia was reduced in width and the lighting reduced.

He had also been shocked to learn that 'reference to the local vernacular' essentially meant the right colour of bricks and mortar; local design features were not considered. The Clerk was asked to check whether the V&D Statement was amongst AVDC's retained policies, and therefore still relevant.
