In light of the fact that the Buckingham River Ouse was polluted with raw sewage in 2017 Buckingham Town Council as a riparian owner of large stretches of the river through the town of Buckingham - disagrees with allowing sewage to be dumped into the river course and therefore registers its concern and objections to the Government's decision not to adopt the stronger measures proposed in the Environment Bill to restrict the discharge of raw sewage into our water courses, allowing water companies to continue the dumping of sewage within our river. The river is used by members of our community for leisure and recreation throughout the year. The Council therefore agrees to write to the Secretary of State for Environment, Food and Rural Affairs registering our concern and asking them to seek to support legislation that restricts the discharge of raw sewage into our rivers at the earliest appropriate opportunity.

NB: Updated costs for hire of a large screen £1.687

Members discussed options towards funding the hire of a large screen.

The Town Clerk explained that a new version of the logo, with hands underneath and the text 'supported by the Town Council' that could be utilised at the event.
