Summer 2020 Newsletter

1. Recommendations

1.1 It is RECOMMENDED that the publication of the Town Council newsletters is cancelled until the restrictions on public movement due to Coronavirus are lifted.

2. Background

2.1 The summer newsletter was scheduled to be printed and distributed at the end of June. The following articles were to be included:

- Cover
- Message from your Mayor (1 page)
- Canal Society (1 page)
- New Town Council and Councillors (2 pages)
- What your local councils do (2 pages)
- Upcoming events (2 pages)
- Past events (1 page)
- Pontio: student interview (1/2 page)
- Community Safety Partnership (1/2 page)
- What did the town council achieve 2019/2020 (2 pages)
- New staff (3/4 page)
- Your views count/Buckingham town councillors (1 ¼ page)
- Back cover/Events Diary (1 page)

2.2 Of those articles the following will not be able, or are unlikely to be able to be produced due to decisions made nationally since the last meeting, leaving the summer edition about 5 $\frac{1}{2}$ to 6 $\frac{1}{2}$ pages short of the usual 16 page edition:

- New Town Council and Councillors (2 pages)
- Past Events (1 page)
- Upcoming Events (2 pages)
- Community Safety Partnership (1/2 page)
- Events Diary (1 page)

Some of the articles might not be ones we would choose at this stage.

2.3 Discussions with our newsletter designer, printer and distributor have revealed that both the printing and distribution company have currently shut down due to

the restrictions in place on work and movement. It's not known whether they will be able to operate in May or June.

3. Online newsletter

3.1 One option going forward would be to continue with the summer edition but reselect articles, and then publish as a digital only output. Unfortunately, this would only be accessible online, and at this time we are producing a lot of digital content already.

3.2 Some residents don't have online access, and we know that these people are more likely to read the print newsletter. We may be better to focus our attention on a print media that could be distributed.

3.3 We would also need to be aware of seeming insensitive with our choice of articles.

3.4 The current situation is changing very quickly. The Communications Clerk has been updating the 'coronavirus' pages of the website every day. Including amendments, corrections and additions as advice from the government is clarified or changes. If we commit to a structured 'newsletter' that can't be edited, even digitally, it runs the risk of becoming out of date quickly and having to be removed.

3.5 If an online newsletter is produced, it is RECOMMENDED that alternative formats are considered.

Communicating with Residents: Alternatives

1. Recommendations

1.1 It is recommended that **option 2: print at home** options be considered as an alternative to the Summer 2020 newsletter.

2. Background

2.1 The summer newsletter was scheduled to be printed and distributed at the end of June. The following articles were to be included and could still go ahead (some would need to be adjusted):

- Message from your Mayor (1 page)
- Canal Society (1 page)
- What your local councils do (2 pages)
- Pontio: student interview (1/2 page)
- What did the town council achieve 2019/2020 (2 pages)
- New staff (3/4 page)

2.2 If report **CSG/195/19** has been agreed and there will be no Summer newsletter edition, members must decide what information they feel must still be circulated to all residents and how that can be done.

2.3 For all the options below content would need to be carefully chosen, judging the mood and need of the community. A Mayor's Message seems appropriate, while other articles might not be needed now.

3. Option 1: online only

3.1 Some of these articles could be added to the website and advertised on social media if needed.

3.2 However not everyone is online, our social media reach would not cover everyone throughout the town.

3. Option 2: print at home options

3.1 The Newsletter Designer could be asked to produce a condensed version of the key information members would like to include in a newsletter at this time, in two versions – a colour version for online use, and a black and white easy print version. This version could be downloaded and printed by neighbours to deliver to

those without internet access or distributed to the Buckingham Hub, Food Banks, etc for distribution with food parcels.

3.2 It is likely that this approach will still miss some people.

3.3 If information is being hand printed and delivered there is some risk of passing on contamination between households, however including this with other essential deliveries being made mitigates this.

4. Option 3: commercial print and distribution

4.1 Royal Mail offer personalised mailing options. This could be used to print and distributed information to residents at 6,083 addresses in the parish whilst postal workers are going about their normal delivery routes.

4.2 The cost for delivery is £500+VAT compared to the usual £425.81, with the product likely to be flyer sized compared to the usual 16-page booklet.

4.3 Printing costs are currently unknown.

4.3 A physical print run of this kind would need to be very carefully written to be accurate for as long as possible. Information and advice has changed rapidly over the last three weeks and the risk of printing something that was contradicted by a change in advice from the government is significant.
