RESOLVED to note that there were apologies from Cllrs P & G Collins, Strain-Clark, Try and Mordue. Apologies also received from County Members Whyte and Chapple.

Cllr Stuchbury reported he would attend a meeting on 6th October at AVDC regarding the unitary council proposals. He informed Members that following his motion to the District Council regarding challenging the footpath access issue, he was waiting to receive news of a proposed solution from Cllr Paul Irwin.

Cllr Stuchbury also briefly reported on his working projects with Children's Services and County highways on the Tingewick Rd development.

Cllr Harvey asked Cllr Stuchbury to report on what was happening with the issue of the Tesco/London Rd roundabout; the petition had been sent in several months ago and promises of resolution from both District and County had amounted to nothing – despite being promised in February 2015.

Cllr Stuchbury responded that he too was very disappointed and frustrated at the lack of action from both Councils

Members **AGREED** that the Town Clerk should write to both AVDC and Bucks County citing all dates and correspondence in which the issue had been raised, expressing deep displeasure and requesting immediate action.

the NPPF despite the Cabinet Member's stated support of NDPs by AVDC Members and Officers. (Cllr Mike Smith)

Members held a long discussion and agreed that as a result of the successful adoption of the Buckingham Neighbourhood Development plan that the Town Council will need to continue to be very diligent with commenting on planning applications, quoting plan policies and specifications.

Proposed by Cllr Smith, seconded by Cllr Hirons and **AGREED** that in view of the District Council's received legal advice and its impact on Neighbourhood Plans that such advice should be provided in full to Town and Parish Councils to equip them in their local planning decisions.

Cllr Cole informed Members that he served as a Magistrate and that there had been magistrates sitting in Buckinghamshire serving the local communities for 640 years. At present Magistrates courts were only in Aylesbury, High Wycombe and Milton Keynes – the proposal was to now close Aylesbury.

Aylesbury supports the Headquarters for the fire, ambulance and police services; Cllr Cole commented that the magistrates court building was a 1980's build and fit for purpose.

Members discussed the importance of local services, particularly for those people attend court for 9am cases, such as families with young children who have to arrange care; or witnesses who may not be inclined to travel further to High Wycombe or Milton Keynes. Members remarked that court activity covers a whole raft of situations and wholeheartedly supported the proposed response on behalf of the Town Council and people of Buckingham.

Cllr Harvey had circulated the following proposed amendment by email:

Europe and the Middle East are in the middle of a huge humanitarian crisis: millions of people are desperately seeking safety and sanctuary. This Council commits to work with all local people and public service partners to make refugees welcome in our town. Moreover, echoing Buckinghamshire County Council's recent commitment, that this Town Council agrees that all Buckinghamshire authorities, together with Police and Health, should work together to press the Government to fund fully the ongoing costs of the refugees, particularly those with high needs.

Naturally this Council supports the fair & lawful application of the 1951 UN Convention on helping refugees (http://www.unhcr.org/3b66c2aa10.html) and all its Articles in particular Article 21 concerning Housing*.

As a consequence and in compliance with this Article, this Council supports giving priority to housing the homeless, including ex Services personnel, in Buckingham & wider Aylesbury Vale, before refugees.

*This Article states: "As regards housing, the Contracting States, in so far as the matter is regulated by laws or regulations or is subject to the control of public authorities, shall accord to refugees lawfully staying in their territory treatment as favourable as possible and, in any event, not less favourable than that accorded to aliens generally in the same circumstances."

Cllr Harvey stated the amendment was simply about extending a welcoming hand to all and sought to find a motion that would unify both sentiments.

Cllr Hirons spoke at length about a trip he had recently taken, visiting towns in both Sweden and Germany where the locality were taking in 100s of refugees and felt that the UK was not pulling its weight in response to the humanitarian crisis. Members voted unanimously in favour of the amended motion, item 10 fell as a consequence.
