## ANNUAL STATUTORY MEETING

## Information

In recent years the Town Council has previously held the Annual Statutory meeting and Mayor Making separately at the beginning and end of May respectively. Members agreed following the 2016 meetings to re-combine them into one meeting. Before this the Fridays 19<sup>th</sup> and 26<sup>th</sup> of May had been provisionally booked. However, these were removed and the 5<sup>th</sup> of May was booked to fit in with the already agreed calendar of meetings for 2017.

Since then the 26<sup>th</sup> of May has already be let to another hirer. The 19<sup>th</sup> has been provisionally booked out.

The Annual Statutory meeting is the meeting where the Mayor is elected for the forthcoming year. This meeting is required to be held in May (and within 14 days of an election in election year).

Members should be aware that there is no requirement to have the meeting on a Friday night; this has just been the convention for Mayor Making previously. In addition it may be necessary to move meetings around so that Chairman of committees are appointed inline, rather than out of sync.
