#### **Bleed Kits**

#### 1. Recommendations

1.1. It is recommended that a one-off payment of £400 be given to the Bletchley Lions Club to pay 50% of the cost of purchasing 10 Bleed Kits for distribution to suitable businesses in the Parish of Buckingham. This funding would come from budget 132/4500 – Future planning and contingencies

#### 2. Background

2.1. Bletchley Lions Club have contacted the Town Council with the following proposal.

"We purchase 10 bleed kits for use in Buckingham, the cost of each kit is £80 the Lions club would donate 50% and the Town Council the other 50% so we are asking the council for £400."

"I have spoken to the following venues in Buckingham,

Kings Head, Woolpack, White Hart, Three Cups, Binn, Zinc Cocktail bar, Mitre, New Inn, the other 3 kits will go into late night venues, The Kebab Shop, Desperate Dans Burger bar and either the Beefeater or McDonald's. I also have 2 kits already from a previous campaign and am thinking of Swan Leisure Centre / youth club and Buckingham rugby club. We have found in other areas that once the posters are up and people aware that other venues ask for a kit."

- 2.2. There was an incident recently in the Town involving a stabbing. This incident has caused obvious public concern and supporting this initiative is likely to be welcomed.
- 2.3. When the Lions Club presented the initiative to Council, Members were very keen to assist.
- 2.4. Whilst Buckingham Town Council have a policy on grants and it is important to maintain the integrity of this policy; under the current circumstances it is recommended that this project be treated as a partnership between the two organisations rather than a purely financial grant. BTC will offer support to the Lions with linking to suitable businesses. However, the money will be donated on the understanding that this is a one-off payment to get the project started and any further money would be subject to the usual grant procedures.

#### Dear Secretary of State,

Congratulations on your appointment as Secretary of State of the Department of Levelling up. I write to request you to consider calling-in the recent planning decision by Buckinghamshire Council, 20/00510/APP. This concerns the erection of 130 dwellings, associated access and parking, landscaping and amenity space and the change of land from agriculture to use as sports pitches and/or recreational open space and informal open space on land West of Moreton Road And Castlemilk in Buckingham.

The site is Phase 3 of a contentious extension to a development on the northern edge of Buckingham. Despite much public concern, the site became part of the Vale of Aylesbury Local Plan. Given that decision, it was considered extremely important that the planning application that came forward dealt with a number of significant and material planning matters in details, such as transport, water management and design. It is of my opinion, and that of Buckingham Town Council, local Buckinghamshire Council councillors and many members of the public, that the council did not properly consider these serious matters and that they do need to be considered in more detail.

In particular, the Town Council says:

"Very strong feelings were engendered in those Councillors who attended the Buckinghamshire Council's Strategic Sites Committee meeting and who spoke at the Interim meeting of Buckingham Town Council on Friday 23rd September. It was felt that the procedure and approach adopted by this Shire Committee and officers was unacceptable to a point that Councillors used the term "apparent bullying" to describe conduct during the meeting in question. Individuals were not moved to moderate this phrase and this, perhaps, demonstrates the depth of feeling about this issue."

I do hope that you will consider the merits of calling this application in, and I can arrange for detailed specifics of the other concerns to be forwarded to you to support this.

Buckingham Town Council response to Local Government Boundary Commission consultation on Buckinghamshire Council wards

#### **Suggested Consultation response:**

Buckingham Town Council has reviewed the proposed wards for Buckinghamshire Council. The current wards have not been recommended as the Local Government Boundary Commission felt that the existing arrangement separating the Parish of Buckingham into two separate wards, each combined with rural areas, does not reflect community identities, or promote effective and convenient local government.

It is to be noted that the proposed ward plan still combines the town of Buckingham with rural areas.

The following confirmation is requested by the Town Council:

- It should be confirmed by the Boundary Commission that the Buckingham ward for Buckinghamshire Council should include all of the Osier Way development, including any housing phases not yet agreed. (Vale of Aylesbury Local Plan site BU046.)
- Having a housing development half in and half out of the ward would create numerous instances of breaking local ties within a settlement, including in terms of transport, schooling, housing and health services.

The following amendment is suggested:

The inclusion of Leckhampstead into the Buckingham ward. The inclusion of Leckhampstead
with the Horwood ward is awkward geographically. Residents of Leckhampstead come to
Buckingham to access schooling, health services and transport. Separating them from
Buckingham excludes the electorate in that area from having access to councillors that also
represent the area and facilities they use.

The following inconsistency is proposed to be resolved, by allocating the Buckingham ward four councillors:

- The addition of Leckhampstead to the Buckingham ward would add 175 to the forecast electorate of the ward, creating a forecast electorate of 15,102. The proposed 3 councillors for this area would create a 5,034 electors per councillors. An 11.3% variance against the average and higher than the 10% sought to demonstrate electoral parity across the county.
- Other wards in Buckinghamshire have 3 councillors for a much lower forecast electorate. For example, Chalfont St Peter has a 11,948 forecast electorate. This is 3,983 electors per councillor. A -12% variance.

- Changing the new Buckingham ward to 4 councillors would result in 3,776 electors per councillor and return some parity in overall representation, as most of the northern wards are recommended to have a higher than average number of electors per councillor.
