Appendix A

9.2.1. (Min. 156/25) Officer's Response on Addington Road Disabled Bay If a disabled bay is no longer required, based on updated resident information, mobility status, or usage, Buckinghamshire Council can initiate the process for its removal.

Any proposed changes to parking restrictions, including the removal of a disabled bay, must go through a statutory public consultation. During this phase, residents and stakeholders are invited to submit their support or objections.

Following the consultation, the Council may approve the removal. If approved, the Traffic Regulation Order (TRO) is updated, and the bay is physically removed by taking down the signage and removing the road markings. This ensures the space is returned to general use and is no longer reserved for Blue Badge holders.

The tree is definitely growing up against the walls and windows of Markham's Court but looks healthy enough. No evidence has been submitted of disease or falling branches.

It is not impossible that this is the result of someone casually dropping a cherry stone into the shrub bed. There are no other trees this end of the site, and there are no applications on the (old AVDC) website since 1993 when the warehouse was converted into flats, and there are no drawings at all, let alone landscaping plans. The tree is quite spindly on a 2018 Google map photo, see below.

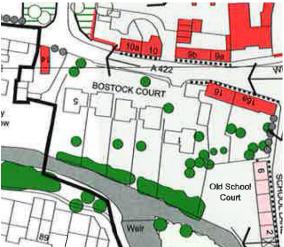
The TPO map indicates two sycamores in the garden fronting West Street, and it seems likely that this is one of them. It is also in the Conservation Area (application suffix KA) but I would have expected a TP application.

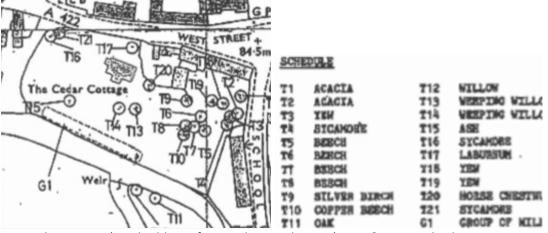




Adjacent Listed Buildings and Protected Trees G

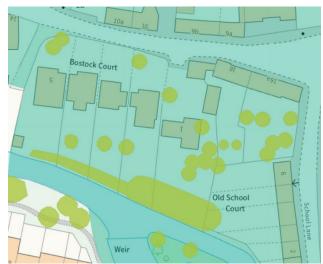

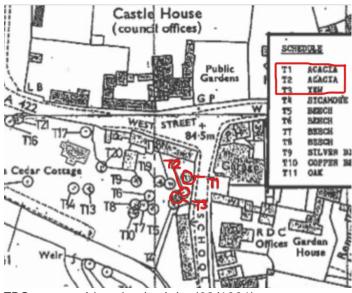

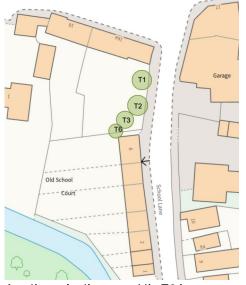
Location plan

Applicant's diagram. His T6 is not a Protected tree; only T1, T2, and T3 are.

The site is the garden of Corner House, at the junction of West Street and School Lane. Some of the trees are visible from the School Lane side, over the garden wall. As can be seen from the description, the work proposed for the three Protected trees is similar to that carried out in 2021. A 2013 application permitted the work on the Yews but not the acacias. Work was also done in 2007 to these same trees.

The applicant has explained that the T1 & T2 marked as "Acacia" on historic TPO plans are actually "Robinia pseudo acacia "Frisia"" not "Acacia dealbata" but have been referred to as "Acacia" to avoid confusion with the TPO plan.

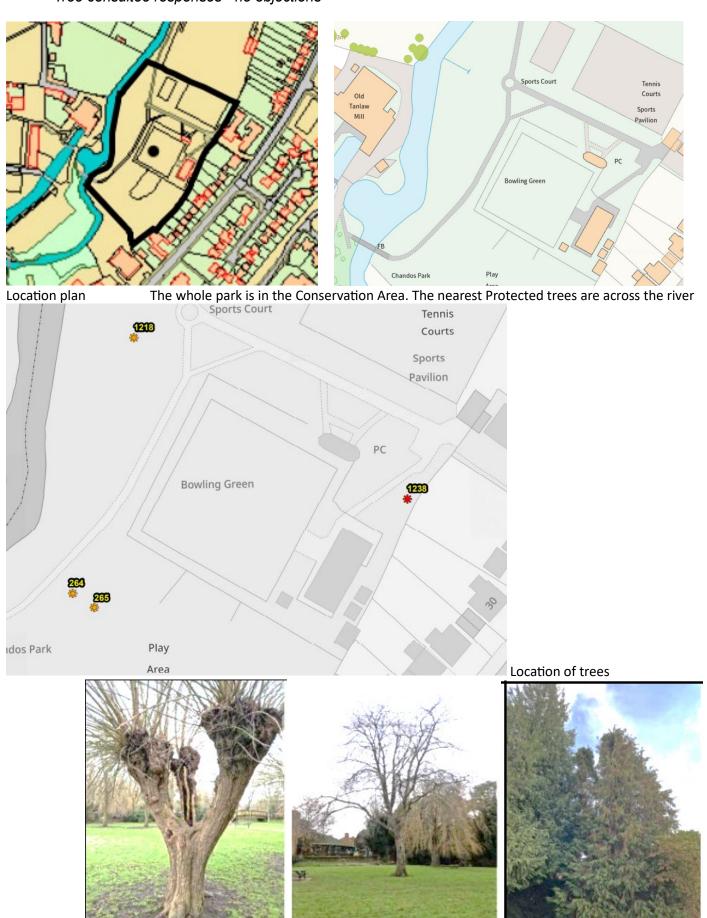

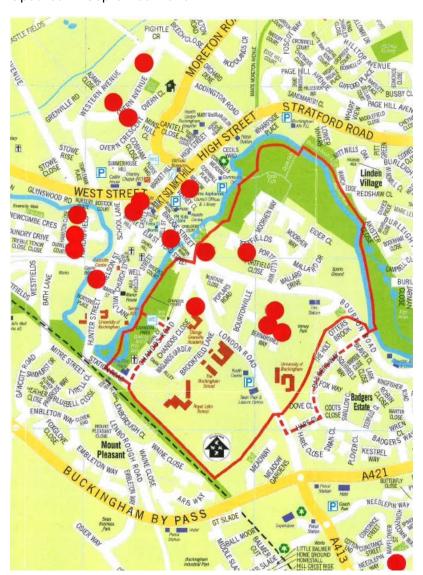
