

Neighbourhood Plan Examiner's Recommendations

1. Recommendation

1.1. It is recommended that Members agree the Independent Examiner's recommended amendments to the Neighbourhood Plan in full.

2. Background

- 2.1. The Neighbourhood Plan is nearing completion of the Examination stage.
- 2.2. The Independent Examiner has written the first draft of his final report and made a series of recommendations to amend the text for clarity and to ensure the Plan meets the relevant legal requirements.
- 2.3. He has commended the Town Council on the high standard of the Plan and Design Code and has concluded that, subject to the Town Council accepting his recommendations in full, he is satisfied that the Buckingham Neighbourhood Plan can proceed to Referendum.
- 2.4. The Working Group has examined each of the Examiner's recommendations in turn and, following the advice of our consultants ONH, made the following recommendations:
 - 1. AGREED to recommend to Full Council to accept the Examiner's recommendations in full, noting that further advice was awaited from ONH on two points.
 - AGREED to recommend to Full Council that upon receipt of the outstanding advice from ONH the Compliance and Projects Manager and the Town Plan Officer are delegated to make the final amendments.
- 2.5. The Examiner has now clarified the two outstanding points and ONH have advised that all the Examiner's recommendations should be accepted in full.

3. Next Steps

- 3.1 If the Examiner's recommendations are accepted in full, Buckinghamshire Council are expected to accept the Plan and schedule a referendum.
- 3.2 If the Examiner's recommendations are not accepted in full the Neighbourhood Plan will not proceed to Referendum and the Plan will need to be withdrawn.
