

## Teen Photography Competition – Terms and Conditions

By entering the Competition, you agree to comply with the following Terms and Conditions:

### Entry Requirements

- All entries must be submitted by **Monday 30th September 2025**.
- All photographs must be taken in **Buckingham** to qualify.
- Entrants must be aged **13–17**. If you are under 18, you must have permission from a parent or guardian to enter. By submitting an entry, your parent/carer/guardian is deemed to have given such consent and to agree to the use of the entry as described in these Terms and Conditions.
- All photographs must be submitted by email to **engagementofficer@buckingham-tc.gov.uk**.

### Image Content

- If your photograph features identifiable people, they must be aware that they are being photographed, and consent must be obtained from all individuals (or their parent/guardian if under 18).
- Entries may be disqualified if it is clear that people in the photograph are unaware, uncomfortable, or embarrassed by the image.

### Copyright & Usage Rights

- You must be the sole author and copyright holder of the image(s) entered.
- Photographers will always be credited alongside their work wherever reasonably possible.
- By entering the competition, you grant Buckingham Town Council a **non-exclusive, royalty-free, irrevocable license** to use, reproduce, and publish the images for any purpose connected with the competition and the Council's promotional activities (e.g. website, social media, printed materials, exhibitions).
- You retain full copyright and may continue to use your images elsewhere.

### Data Protection

- The information you provide will be collected and stored by Buckingham Town Council in accordance with the **UK General Data Protection Regulation (UK GDPR)** and the **Data Protection Act 2018**.
- Data will be used solely for the administration of this competition, including publishing the winner's name unless you request otherwise.
- Your details will **not** be shared with third parties or used for future marketing without your consent.

- To the maximum extent permitted by law, Buckingham Town Council accepts no responsibility for any loss, damage, injury, cost, or expense suffered by entrants in connection with the Competition.
